Integrated GRC frameworks help agencies:

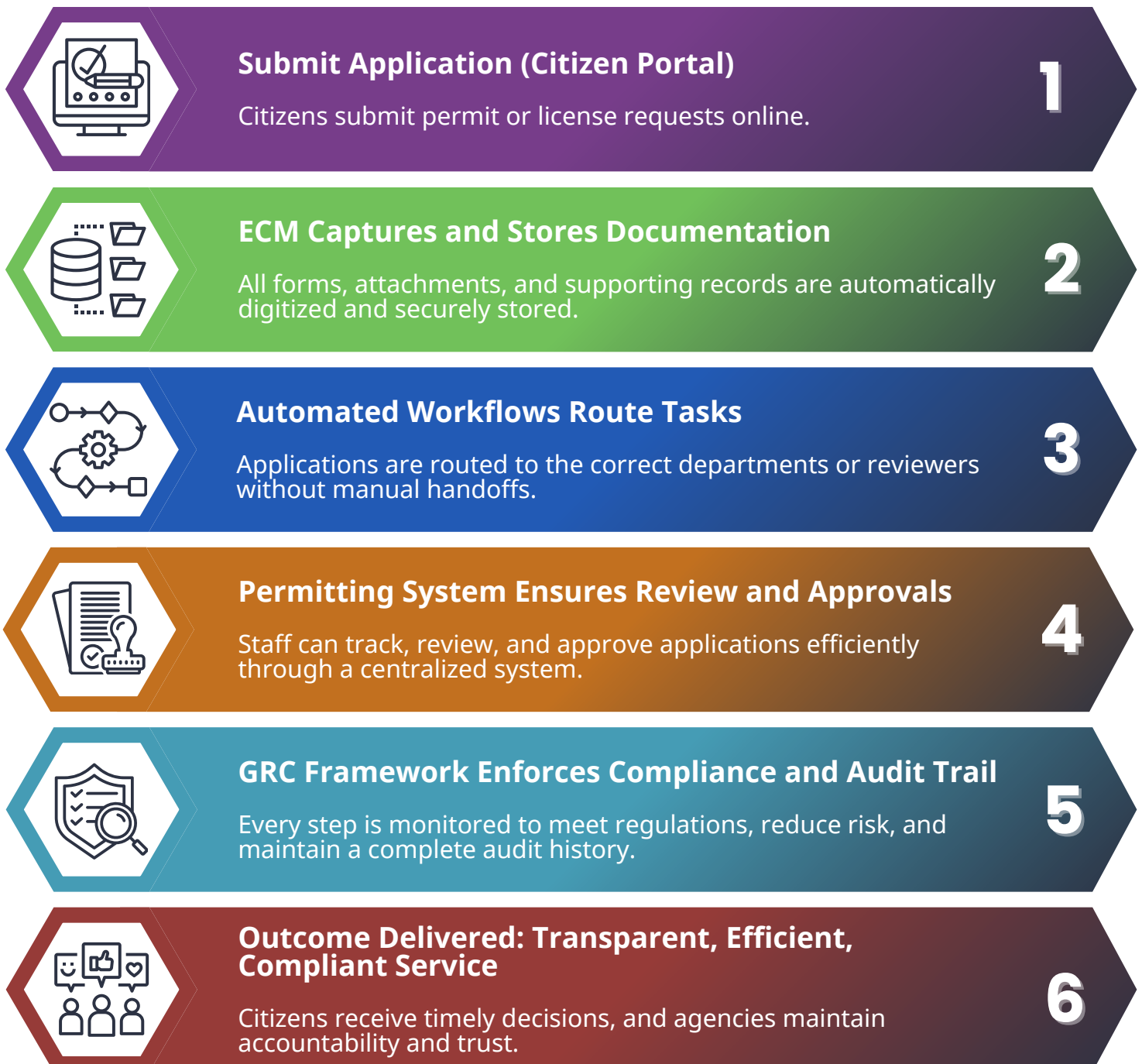
- Monitor compliance with local, state, and federal regulations.
